

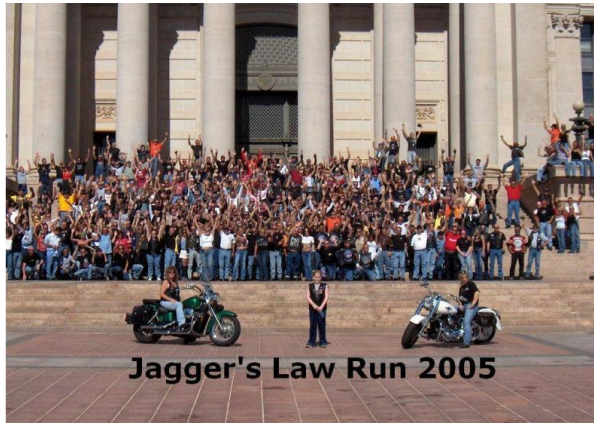
# Anyone Can Join

Over two-thirds of car/motorcycle crashes are caused by drivers, not motorcyclists. In most cases the driver does not see the motorcyclist in time. We cannot prevent motorcycle accidents from occurring. However you can make a difference by being there through emotional and financial support.



The Downed Bikers Association was founded in September of 1999. The Downed Bikers Association, also known as 'DBA' has six active chapters in Oklahoma. The founding chapter Oklahoma City, Western Plains, Enid, Tulsa, Twin Rivers and the Foothills chapter. All of the Downed Bikers Association Chapters are registered corporations with the State of Oklahoma and have their own Board of Directors. Each chapter files and maintains its own 501(C) 3 charity status with the Internal Revenue Service. The National Board of Directors was separated from the founding chapter in accordance with the Bylaws in 2014 in an effort to maintain continuity in policy, ethics and procedures within all of our chapters and to respond to the growing interest in new chapters from in and outside the state of Oklahoma. As with all chapters of the DBA, no one on the National Board of Directors is compensated for their work.



In April of 2006 a Senate measure to help protect motorists and make Oklahoma's roads safer was signed into law by Governor Brad Henry. With the help of the folks at ABATE, the Jagger's Family, the Downed Bikers Association and motorcyclists from around the state, Senate Bill 1929, authored by Senator David Myers and Rep. Jim Newport, created the David Jagger's Law, named after a long-time motorcycling enthusiast and active member in the Downed Bikers Association who was killed by a negligent, reckless motorist while riding his motorcycle.
